These Local Rules and Terms of Competition supersede all other local rules.

Unless otherwise noted, the penalty for breach of a Local Rule is the General Penalty. **Strokeplay:** Two strokes

SUPPLEMENTARY LOCAL RULES

1. Out of Bounds (Rule 18)

a. Boundaries have been established as follows:

- i) The 9-hole course to the right of hole 10, 13, 15, 16, 17, 18 and behind green on hole 6 as defined by white stakes and/or white line.
- ii) The Driving range and short game area to right of hole 18 as defined by white stakes and/or white line.
- b. **Internal Out of bounds.** During play hole of 11, right side of the hole, defined by white/black stakes, is out of bounds. These black/white stakes are boundary objects during play of hole 11. For all other holes, they are immovable obstructions.

2. Penalty areas

- a. Red penalty area with a same distance lateral relief on opposite side: **none this week.**
- b. All unmarked ditches are red penalty areas.
- c. The red penalty areas **right on hole 3 and left on hole 16** defined on only one side extends to infinity.
- d. The depressions on holes 10th, 11th, 12th and 13th are to be treated as part of the general area and not as penalty areas.

3. Abnormal Course Conditions (including immovable obstructions) (Rule 16.1)

- a. When taking relief under 16.1, the nearest point of complete relief must be determined without crossing over, through or under the safety net on hole 2.
- b. Staked trees.
- c. Electric fence.
- d. Relief from interference by electric fence located in the *penalty area* behind putting green on hole 3 is allowed under Rule 16.1b, with the following modifications:
 - Reference Point: The *nearest point of complete relief* must be in the *penalty area*.
 - Size of Relief Area Measured from Reference Point: One *club-length*, but with these limits:
 - Limits on Location of Relief Area:
 - » Must be in the *penalty area* in which the ball came to rest,
 - » Must not be nearer the *hole* than the reference point, and
 - » There must be complete relief from all interference by the *immovable obstruction*.
- e. The black/white stakes on hole 11 (internal out of bounds) are immovable obstructions in the play of any other hole.
- f. Big stone in the right bunker hole 18 GUR, blue stake

4. Integral objects

- a. All stone outcrops and large stones on the course.

5. Wrong green (Rule 13)

- a. The turf green behind hole 5 is wrong putting green.
